Presidents Report Jéaux	<p>Resolutions presented: A resolution titled: Ultrasound-Guided Peripheral Intravenous Access was passed around for attendees to review. This resolution is being brought forward by Jean Proehl. The intent is to get a national position statement on this topic. There are 11 resolutions and 12 bylaw changes being brought to the floor of General assembly in September. The August meeting will be the forum for presenting those resolutions that are going to be brought forward.</p> <p>All WA-ENA members are encouraged to vote in the national elections.</p> <p>In an effort to go green, An online archival site has been purchased named fat cow to store all of our council’s documents.</p>	

	<p>Booth planning for the national conference fundraising suggestions: IPAD II, Southwest airlines tickets, wine and wine tours, a bicycle, or a package to our international educational conference. Discussion was made on how to purchase the big ticket item. Also discussed selling WAENA pins. The education chair will form a committee to plan this fundraising at the national conference.</p> <p>Motion: WAENA set up a booth at the national conference. Moved, Seconded, and passed.</p> <p>Motion: Increase the budget to fundraising inclusive of the cost of the booth to \$1000.00. Discussion ensued. Move, Seconded, and passed.</p> <p>WAENA attire: Should the state council have the ability to sell attire and make it available from the website or have a pre-order at each meeting? The challenge is to have the shirts available for delegates as needed. There is potential of having the logo changed. There was discussion about having the shirt sizes on the delegation application and have the cost deducted from the delegate stipend. <p>President-Elect's Report Roger</p>	<p>There is an opportunity for our State Council to apply for a National Award: The State Achievement Award. As a council we are doing everything required except having a strategic plan in place. This should be one of our goals to accomplish as a council. This can be set up as a WebEx. A sign up sheet was passed around for volunteers to work on development of the strategic plan.</p> <p>Governors Steering Committee: Gearing up for the cardiac and stroke system being implemented. Also looking closely at injury from falls. A grant is being applied for by Harborview for fall injury prevention.</p> <p>Survey Monkey: Presentation of reason and scope of survey. This was open for about 10 weeks for responses. Total of 113 responses or 10% of WAENA membership. Discussion areas of opportunity for improvement. Reviewed meeting dates/locations, reviewed meeting structure, identified areas for strategic planning and opportunities to partner with other organizations. These results will be available on the web and printed in the vital lines. Discussion ensued about development of local chapters.</p> <p>Educational Event with Canada: Discussion about a joint educational conference with NENA,</p>	

	<p>(British Columbia) and Washington. NENA will be in contact in a couple of weeks after they meet. Will be looking at locations that are easily accessible.</p> <p>Website: There has been a seamless transition to a new hosting company.</p> <p>Blast Emails: 20% open rate of these blast emails. The links can be traced as to who is opening them.</p> <p>August 25 meeting at the Red Lion at SeaTac. There is a block of room made. All of this information has been made current on the website.</p> <p>Reviewed revised SOP's. Change in format of council chairs and a role description for the chairs. <p>Education Vision Council Chair: Tami Wheeldon</p>	<p>Summit to Sound ACEP conference on May 18-20th, at Bell Harbor International Conference Center in Seattle. There are 23.5 category credits available for this that is reciprocal for CNE's.</p> <p>A link to the department of health and CE required for licensure will be placed in the vital lines.</p> <p>A committee is being put together to start the work of the Canada/Washington educational event for 2012.</p> <p>Education assistance award was awarded to Diana Meyer in the amount of \$1000.00. <p>Membership Vision Council Chair: Karin Kloppel</p>	<p>1124 members, net increase of 31 members since January. 20 have joined in April. 39 members have let there membership expired. Highest membership so far in the history of this state council. Any addresses need to be changed online. Discussion ensued on how to reach out to those members who have let there membership expired. For example a post card or form letter and have signatures from attendees at the meeting. A suggestion was made to use our membership grant money for this. Also posting the benefits of membership should be posted in department breakrooms, etc.</p> <p>Voting for national elections begins May 12. Be sure to vote.</p> <p>Nominations are now being accepted until May 15 for the 2011WAENA elections Nominations for President elect, secretary, and treasurer elect and be sent to Karin.</p> <p>Registration for the Annual conference will open for early registration May 5 and closing August 5 2011.</p> <p>Delegate applications have been revised. These changes were presented to the attendees. The goal is to have all delegates notified by August 1st. The total number of delegates is capped at 700 with 5 national delegates, this number is prorated. There will be discussion at general assembly this year of how the 700 delegate seats are filled. If states do not use all of those seats can they be level loaded to another state. The goal is to have a full house of delegates.
